1. All buyers must obtain a Buyer's Number before bidding. Registration for your buyer's number implies that you agree to all the terms and conditions set forth herein.
2. All items are sold "as is", "where is". Information about the lots has been provided by the seller and no guarantee of accuracy is expressed or implied by the auctioneer.
3. Lowering of the gavel, stating "sold" , and the auctioneer's acknowledgment of your buyer's/bidder's number indicates a successful bid.
4. All sales are final.
5. All pieces purchased must be paid for on the date of the sale by 6:00 p.m. No exceptions will be made.
6. All pieces purchased must be removed by 7:00 p.m. on the date of the sale. Each item left will be charged a \$10.00 per day (or any portion of a day) storage fee for a maximum of 10 days. Thereafter, items left will be returned to the seller, the \$100.00 storage fee per item will be retained, and any excess paid will be refunded to the buyer.
7. If your bid is successful you will be obligated to pay:
 - The bid price
 - Plus a 12% buyers premium
 - Plus a 3% credit card fee on all credit card payments
 - Plus 7.25% Calif. sales tax.
8. Although all reasonable care will be taken with sold items, Johnson Gallery is not responsible for damage to any article after sale.
